

RESOLUTION NUMBER R- 270972

ADOPTED ON MAY 16 1988

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for GIRLS' CLUB OF SAN DIEGO BUILDING IMPROVEMENTS AND ADDITION, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on MAY 16 1988, and bearing official Document No. NO. 119578, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for GIRLS' CLUB OF SAN DIEGO BUILDING IMPROVEMENTS AND ADDITION.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute for and on behalf of said City, an Amendment to Agreement with Girls' Club of San Diego, filed in the office of the City Clerk as Document No. RR-264225 on October 14, 1985, increasing the maximum compensation by \$3,200.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$198,551 (\$167,051 from Community Development Block Grant Fund 18520/5812/1204 Girls' Club of San Diego Improvements and \$31,500 from Capital Outlay Fund 30244, CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD & OTHER CITY COSTS FOR FEDERAL GRANT PROJECTS) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
