
ADOPTED ON MAY 16 1988

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$165,000 from Fund 10510, Account No. 4151 Job. Order No. 269184, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
