ADOPTED ON MAY 31 1988


BE IT RESOLVED, by the Council of The City of San Diego, that the City Council, acting for and on behalf of the San Diego Open Space Park Facilities District No. 1, having heard all protests against the acquisition of that property described in that Resolution of Intention No. R- 270870, adopted by the City Council on MAY 02 1988, 1988, hereby overrules such protests and determines that it would be in the public interest to acquire said property for open space park purposes.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to offer to purchase said property.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$775,000 as payment for said property and related costs from Open Space Park District Bond Fund 79103 is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deed to said property without further Council action.
