BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. MOTOROLA C & E, INC., 2. GENERAL ELECTRIC COMPANY, 3. CALIFORNIA MOBILE COMMUNICATIONS, 4. BEST TECH, INC., 5. KING RADIO CORPORATION, 6. COUNTY WIDE COMMUNICATIONS and 7. PANAMERICAN TECHNOLOGY, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of COMMUNICATIONS EQUIPMENT as may be required for a period of eight (8) months beginning June 1, 1988 through January 31, 1989, per prices on file in the Purchasing Department, with an option to renew contracts for an additional one (1) year period with price increases not to exceed 12% of original contract pricing as follows:

1. MOTOROLA C & E, INC. for Items 1A, 1C, 1E, 4A, 4B, 5, 6A, 7, 8A, 8B, 9A, 10B, 11A, 12A, 12B, 12C, 12D, 12E, 14A, 15B, 16, 17, 18, 19B, 20A, 21B, 22A and 23A; terms net 30 days, plus sales tax.
2. GENERAL ELECTRIC COMPANY for Items 2A, 9B, 11B, 13A, 15A, 20B, 22B and 23B; terms net 30 days, plus sales tax.
3. CALIFORNIA MOBILE COMMUNICATIONS for Items 1B, 1D, 6B, 10A, 19A and 21A; terms net 30 days, plus sales tax.
4. BEST TECH, INC. for Items 3A and 3B; terms net 30 days, plus sales tax.
5. KING RADIO CORPORATION for Item 2B; terms net 30 days, plus sales tax.
6. COUNTY WIDE COMMUNICATIONS for Item 13B; terms net 30 days, plus sales tax.
7. PANAMERICAN TECHNOLOGY for Item 14B; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED that the Purchasing Agent is hereby authorized to enter into a contract with the next low acceptable bidder if for any reason a bidder is unable to furnish an item contracted for.
