AND THE CITY OPERATIONS BLDG. as may be required for a period of one (1) year beginning July 1, 1988 through June 30, 1989, at a cost of \$5.75 per worker hour, for a total estimated cost of \$79,000.00; terms .05% 21 days; with options to renew contract for four (4) additional one (1) year periods, with price escalations not to exceed 10% of price in effect at the end of prior year.
