RESOLUTION NUMBER R- 271038

ADOPTED ON MAY 31 1988

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Auditor and Comptroller is hereby authorized to open Fund No. 78025 for the purpose of depositing Public Utilities Commission Case 8209 Utility Undergrounding Allocation Funds for the Convoy Street (Othello Avenue to Ronson Road) Underground Utility District.


2. That the City Treasurer is hereby authorized to receive these funds from the San Diego Gas & Electric Company.

3. That pursuant to Council Policy No. 800-2, payment is hereby authorized to all property owners in the Convoy Street (Othello Avenue to Ronson Road) Underground Utility District as reimbursement for electrical service underground conversion work done on private property whenever the required length of trenching exceeds 15 feet, from Case 8209 funds held by the City Treasurer for this purpose.

4. That the City Auditor and Comptroller is hereby authorized to return to San Diego Gas & Electric Company any

undisbursed funds upon written notice from San Diego Gas & Electric Company to the City that all electric service conversions within a particular district have been completed.
