WHEREAS, on August 5, 1987 the City Manager recommended to the Public Services and Safety Committee that the City implement a gang diversion program that would focus primarily upon job training and employment for gang members and at-risk youths; and

WHEREAS, it was further recommended that funding in the amount of \$150,000 from the FY'88 General Fund Unallocated Reserve be used for this purpose; and

WHEREAS, because the RFP process will not be completed, and the program will not be implemented until July 1 or thereafter, the Manager is requesting that Council adopt a resolution authorizing the Auditor and Comptroller to transfer the \$150,000 from the FY'88 General Fund Unallocated Reserve to the FY'88 General Fund Allocated Reserve for the express purpose of funding the implementation and operation of a gang diversion program in FY'89; and

WHEREAS, on completion of the RFP process, the Manager will return to the Council with a request for authorization to execute a contractual agreement and expend the funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$150,000 from the Fiscal Year 1988

General Fund Unallocated Reserve to the Fiscal Year 1988 General Fund Allocated Reserve for expenditure in Fiscal Year 1989 on a gang diversion program to be implemented through a Request for Proposals (RFP) process.
