

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$90,000.00 made payable to Marvin and Lucille Gunderson, and their attorney, C. Brant Noziska, in full settlement of the lawsuit and of all claims.
