

- 1. That the City Auditor and Comptroller is hereby authorized to add CIP No. 29-658, Skyline Community Park Lighting to the FY 1988 Capital Improvements Program.
- 2. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$7,000 from Park Service District Fund 15640 to CIP No. 29-658, Skyline Community Park Lighting.
- 3. That the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to the agreement with P & D TECHNOLOGIES, for the design of multi-sports field lighting at Skyline Community Park, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 271061.
- 4. That the expenditure of an amount not to exceed \$7,000 from CIP No. 29-658, Skyline Community Park Lighting, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above first amendment to agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
