BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$800,000 from CIP No. 29-406.0, Nobel Athletic Area - Acquisition and Development Park Service District Funds, [\$24,478 from PSD Fund 11481, \$583,053 from PSD Fund 11482, \$181,457 from PSD Fund 11483, and \$11,012 from PSD Fund 13460], is hereby authorized, solely and exclusively for the purpose of providing funds for the above agreement.
