BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with MAAS Diagnostic Laboratories for provision on an as required basis of police initiated blood drawing services for law enforcement purposes from April 1, 1988 through March 31, 1989, with options for four one year extensions, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 271071.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend funds on an as required basis

solely and exclusively for the above purpose, including a sum not to exceed \$8,000 from Fund 100, Department 110, Organization 222, Job Order 4151, during Fiscal Year 1988.
