BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF FIRE DEPARTMENT COMMUNICATIONS BUILDING.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$2,332,040 from Federal Reserve Sharing Fund 18014, CIP No. 33-069 FIRE DEPARTMENT SUPPORT SERVICES COMPLEX is hereby authorized solely and exclusively for the purpose of providing
