ADOPTED ON JUNE 06, 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of CHRISTOPHER WYER, as successor trustee under Trust PR-46933, executed in favor of The City of San Diego, a copy of which deed is on file in the Office of the City Clerk as Document No. RR-271098, conveying to said City portions of Section 23, Township 14 South, Range 4 West, S.B.B.M., being a vacant 6.4-acre parcel of land on the westerly side of Carmel Valley Road, and which parcel is to be subsequently deeded to the State of California for open space preservation, as more particularly described in said deed, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1.55 million from Fund 39033, Beau Soleil Property (SAFCO), toward the acquisition of the above property, which was appraised at \$1.68 million, for just compensation purposes, is hereby authorized and approved.

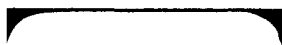
BE IT FURTHER RESOLVED, that the acceptance of the generous donation of Christopher Wyer, as successor trustee under Trust PR-46933, in the amount of approximately \$140,000, which represents the difference between the appraised value of \$1.68 million, plus closing costs, and the actual funds expended for the site, is hereby authorized and approved.


