RESOLUTION NUMBER R- 271104

ADOPTED ON JUN 06 1988

WHEREAS, The City of San Diego and the County of San Diego have jointly cooperated in providing regional employment and training services through the creation of a local consortium; and

WHEREAS, that cooperation is formalized in a Joint Exercise of Powers Agreement which is due to expire on September 30, 1988 and a committee has met and recommended that the cooperative agreement be continued for an additional five years, until September 30, 1993; and

WHEREAS, the agreement provisions have been reviewed by the Regional Employment and Training Consortium (RETC) Policy Board who concurs in the adoption of a continued partnership between the City, County, and the Community; and


WHEREAS, the agreement has been updated and the language simplified wherever possible; and

WHEREAS, the Board of Supervisors and the City Council are each being asked concurrently to adopt the proposed Joint Exercise of Powers Agreement to continue RETC; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Joint Exercise of Powers Agreement between the City of San Diego and the County of San Diego continuing the San Diego Regional Employment and

Training Consortium (RETC), under the terms and conditions set forth in the Joint Exercise of Powers Agreement on file in the office of the City Clerk as Document No. RR- 271104 .
