WHEREAS, R.E. HAZARD CONTRACTING COMPANY, a California corporation, has requested an exchange of water and drainage easements; and

WHEREAS, the easements being acquired are being granted on Parcel Map T.M. No. 87-0937; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

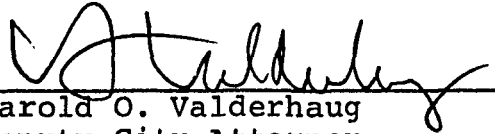
WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 271144 quitclaiming to R.E. HAZARD CONTRACTING COMPANY, all of the City's right, title and interest in the water and drainage easements in Lots 5 and 6 of Carroll Ridge Unit No. 1, Map No. 9411, as more particularly described in the quitclaim deed, in exchange for water and drainage easements as granted on Parcel Map T.M. No. 87-0937.

2. That the City Clerk shall cause the quitclaim deed, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
