ADOPTED ON JUN 13 1988

WHEREAS, House of Representative Bill 4127 (Udall) and Senate Bill 2199 (Chafee) created the American Heritage Trust Act to provide a better funding mechanism for the existing Land and Water Conservation Fund, and the Historic Preservation Fund programs, a self-perpetuating trust; and


WHEREAS, on January 19, 1988, the City Council unanimously adopted R-270189, which supported Congressman Udall's proposed legislation, even though the bill had not yet been introduced; and

WHEREAS, on May 18, 1988, the Rules Committee reviewed Intergovernmental Relations Department Report No. 88-19, which recommends supporting HR 4127 (Udall) and SB 2199 (Chafee) and approved same unanimously (3-0); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation to support HR 4127 (Udall) and SB 2199 (Chafee), as set forth in IRD Report No. 88-19, be and the same is hereby adopted.
