RESOLUTION NUMBER R- 271147

ADOPTED ON JUN 13 1988

WHEREAS, federal and state grant funds are applied for by The City of San Diego and are used to supplement local programs; and

WHEREAS, grant funds are becoming increasingly important to maintain existing levels of service; and

WHEREAS, the Mayor and City Council have placed greater priority on acquiring grant funding; and

WHEREAS, since the November 4, 1987 report to the Rules Committee on the status of grant funding, one grant funded project totalling \$102,700 has been completed, eighteen additional projects totalling \$18,601,795 have become active, and proposals have been submitted for eight potential projects totalling \$12,514,000; and

WHEREAS, the City Manager has identified a list of projects totalling \$1.8 billion in unfunded needs which the Intergovernmental Relations Department will utilize when grant funding opportunities become available; and

WHEREAS, after monitoring grants activities on a quarterly basis, the Intergovernmental Relations Department has determined that not enough activity occurs to warrant reporting grant activities this frequently; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council accepts Intergovernmental Relations Department Report No. 88-17, the Second Status Report on Grant Activity and List of Unfunded Needs that are Suitable for Grant Funding.

BE IT FURTHER RESOLVED, that the City Manager and Intergovernmental Relations Department be and they are authorized to amend Administrative Regulation 1.80 to require the status of grants to be reported semiannually.
