RESOLUTION NUMBER R- 271180

ADOPTED ON JUN 13 1988

WHEREAS, AB 3298 (Killea), as amended April 14, 1988, proposed enactment of the Killea-Cortese Solid Waste Recycling Act of 1988, which would set forth statewide policies for the development and enactment of local recycling programs; and

WHEREAS, AB 3298, as currently written, would abrogate much of the authority currently provided to local agencies for recycling and waste management; and

WHEREAS, the City believes that existing state and county solid waste management planning processes should be utilized to develop and implement recycling plans and that these plans be submitted to the state at the time of the next scheduled review of the County Solid Waste Management Plan; and

WHEREAS, state funding should be provided to assist localities in meeting the initial costs of program planning and public information; and

WHEREAS, the City also believes that the state should define, in detail, the baseline against which any imposed recycling objectives are to be measured, and specific timeliness for meeting the requirements; and

WHEREAS, the City believes that local recycling plans should require proposals for the development of fifty or more residential housing units and commercial and industrial projects utilizing 10,000 square feet or more of land shall provide for the storage of and access to designated recyclables; and

WHEREAS, the City believes that the state, as well as local governments, should provide a ten percent procurement preference for the purchase of recyclable materials; and

WHEREAS, the state should encourage coordination of local government recycling plans and programs to formulate regional recycling strategies; and

WHEREAS, the City believes a statewide recycling committee should be created, with strong representation from local governments, to advise state agencies and the legislature on the implementation of recycling legislation; and

WHEREAS, the City believes there should be a strong state role in evaluating and encouraging markets for recycled materials; and

WHEREAS, the state should be responsible for administering public information programs to disseminate information about recycling; and

WHEREAS, AB 3298 (Killea) was presented to and reviewed by the Rules Committee on May 18, 1988, said committee voting unanimously to support the bill and seek amendments; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby declares its support for AB 3298 (Killea).

BE IT FURTHER RESOLVED, that the Intergovernmental Relations Department be and is hereby directed to seek amendments to AB 3298 (Killea) as specified above.

BE IT FURTHER RESOLVED, that the Council declares its support, pursuant to Council Policy 900-6, for related recycling bills AB 4243 (Clute), AB 4607 (Brown), AB 2831 (La Follette), AB 3746 (Eastin), SB 2037 (Rosenthal, et al), AB 3761 (Connelly and Hauser), and AB 3299 (Killea).
