1. That the City Manager be and he is hereby authorized and directed to execute, for and on behalf of The City of San Diego, an Amendment to Subdivision Improvement Agreement for Villa Colina Unit No. 2, on file in the office of the City Clerk as Document No. RR-253907, to provide for the substitution of Appel Development Corporation for Tierra Santa L-L Partnership, as subdivider.

2. That the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by May 1, 1989, as provided in the Amendment to Subdivision Improvement Agreement, on file in the office of the City Clerk as Document No. RR-271195.

3. That Performance Bond No. SUR 05 82 47, issued by Golden Eagle Insurance Company, in the amount of \$39,088.00 is hereby accepted as the surety for the required improvements in the subdivision, is substituted as Exhibit C to the agreement, and Performance Bond No. SC 731 0590, issued by The American Insurance Company, in the amount of \$93,500.00, is hereby released.
