RESOLUTION NUMBER R- 271197

ADOPTED ON JUN 20 1988

WHEREAS, the City Council adopted Resolution No. R-261765 on October 22, 1984, which provided for a street vacation under Section 8330 of the California Streets and Highway Code; and

WHEREAS, the proposed vacation of Kearny Mesa Road northeasterly of Convoy Street and Aero Drive and southerly of the easterly extension of the southerly line of Parcel "B" of Nichols Ridge, Map 4883, is all within the boundaries of the proposed Parcel Map (TM 83-0368); and

WHEREAS, that resolution of vacation inadvertently omitted portions of Convoy Street; and

WHEREAS, it is necessary that the resolution of vacation include the excess portion of Convoy Street north of Aero Drive and adjacent to Kearny Mesa Road within the proposed Parcel Map (TM 88-0336); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution R-261765 be amended as follows:

1. That Kearny Mesa Road northeasterly of Convoy Street, the excess portion of Aero Drive easterly of Convoy Street, and the excess portion of Convoy Street northerly of Aero Drive and adjacent to Kearny Villa Road, all within the boundaries of the boundaries of the proposed Parcel Map (TM 88-0336), as more particularly shown on Drawing No. 15887-B on file in the office of the City Clerk as Document No. RR- 271197, which is by

this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the resolution shall not become effective unless and until the final Parcel Map (TM 88-0336) has been approved. In the event the final Parcel Map is not approved by November 1, 1990, this resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned Parcel Map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

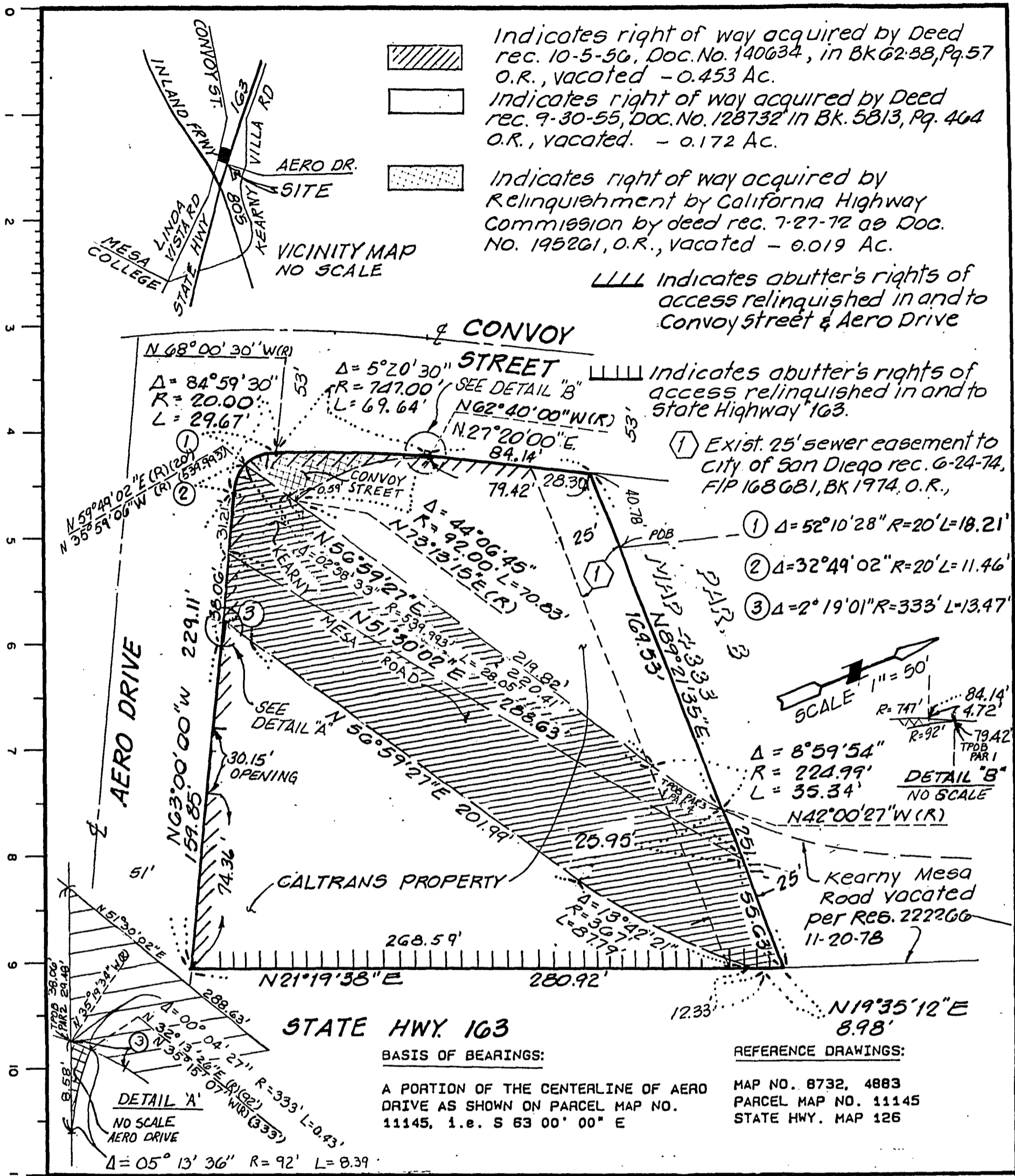

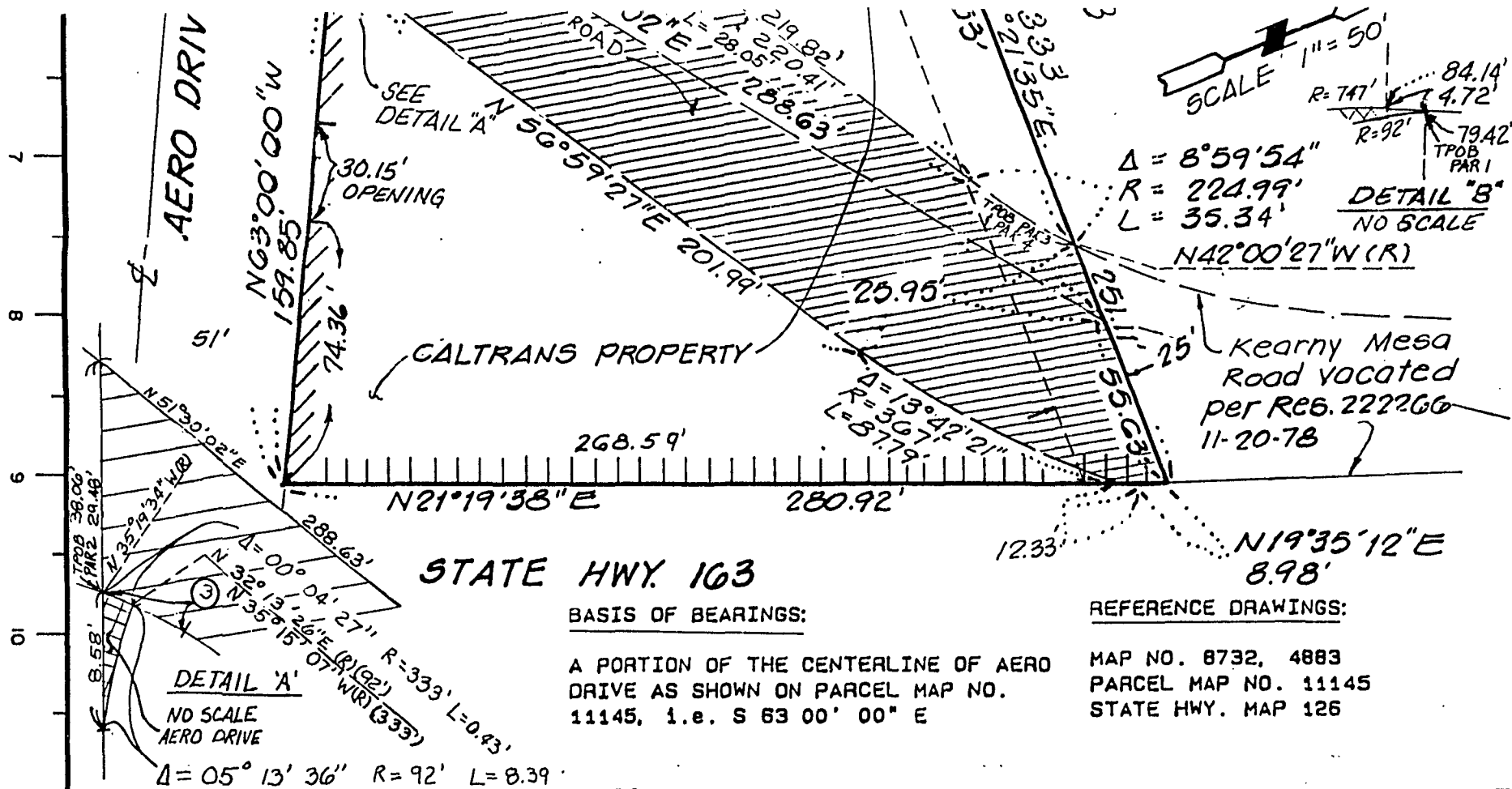
