WHEREAS, there were relinquished to The City of San Diego, by Subdivision Map No. 5096, certain abutter's rights of access in and to Navajo Road; and

WHEREAS, the Building Inspection Department has requested that the City revest these abutter's rights of access in the property to NAVAJO LAKE MURRAY PARTNERS to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and


WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that those certain abutter's rights of access adjacent to Lot 1 of Subdivision Map No. 5298, as more particularly described on Drawing No. 17242-B, a copy of which is attached hereto and by this reference incorporated herein, are hereby revested in said property for the benefit of the owner thereof and its successors in interest.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to deliver a certified copy of this resolution, attested by him under seal, to the Building Inspection Department for further handling.
