RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF SAN DIEGO, CALIFORNIA, AUTHO-  
RIZING EXECUTION OF UTILITY ASSIGN-  
MENT AGREEMENTS

(Assessment District No. 4010 [Otay International Center])

WHEREAS, the CITY COUNCIL of the CITY OF SAN DIEGO, CALIFORNIA, has, pursuant to the provisions of the "Municipal Improvement Act of 1913", being Division 12 of the Streets and Highways Code of the State of California, by adoption of its Resolution of Intention, declared its intention to order the authorize the financing of certain works of improvement, together with utility facilities and appurtenances, in a special assessment district known and designated as ASSESSMENT DISTRICT NO. 4010 (OTAY INTERNATIONAL CENTER) (hereinafter referred to as the "Assessment District"); and,

WHEREAS, pursuant to Section 10110 of the Streets and Highways Code of the State of California, it is required that prior to the time that any works of improvement are ordered to be financed pursuant to said proceedings, the legislative body shall enter into an agreement with the public agencies or regulated public utilities who will have the legal title to the facilities, and further stating that said improvements shall thereafter constitute a part of their system; and,

WHEREAS, at this time, certain Utility Assignment Agreements have been submitted and reviewed pursuant to the authorization of Section 10110 of said Streets and Highways Code.

NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

SECTION 1. That the above recitals are all true and correct.

SECTION 2. That the Utility Assignment Agreements, herewith submitted, relating to the construction and installation of certain improvement facilities that will be under the ownership, management and control of other public agencies or regulated public utilities, are hereby approved. The following listed Agreements are hereby authorized for execution by the City Manager. Said Utility Assignment Agreements relate to facilities to be owned by the following listed public agencies or regulated public utilities:

- A. OTAY WATER DISTRICT
- B. SAN DIEGO GAS & ELECTRIC COMPANY
- C. PACIFIC BELL

SECTION 3. That immediately upon execution, conformed copies of said Utility Assignment Agreements shall be transmitted to the offices of the respective public agency or utility company, together with a copy of this Resolution.
