WHEREAS, the people of San Diego have invested over \$2,200,000 in a ten-year restoration of the organ and pavilion; and

WHEREAS, no public musical instrument in America has received better care, use, and appreciation than has San Diego's Spreckels Organ; and

WHEREAS, the Spreckels Organ Society has been recently founded for the purpose of promoting the expanding use of this musical world treasure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of all of the citizens of San Diego, hereby expresses this special recognition of the Spreckels Organ and appreciates the benefit and enjoyment it provides to the citizens and visitors of San Diego.

BE IT FURTHER RESOLVED, that Monday, June 13, 1988 be and it is hereby designated as "Spreckels Organ Day."
