RESOLUTION NUMBER R-271242

ADOPTED ON JUNE 22, 1988

WHEREAS, Item-602 on the Council agenda of June 22, 1988 concerned a proposal to amend the Progress Guide and General Plan by selecting a Growth Management Element to replace the Guidelines for Future Development; and

WHEREAS, it is intended to place this matter on the November, 1988 ballot for ratification by the voters of San Diego; and

WHEREAS, it is necessary to reschedule and notice Council meetings in July to provide for additional meetings for hearings on the Growth Management Element of the Progress Guide and General Plan; and

WHEREAS, the Council voted unanimously (6-0) to set Council hearing meetings in regard to this matter and expressed its intent to set such schedule by the unanimous vote; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that notwithstanding the Permanent Rules of the Council, Municipal Code section 22.0101, Rule 1, which is hereby waived for said purpose, the following Council meeting dates be and they are hereby established and scheduled for the purposes specified:

2. July 18 and 19, 1988 at 10:00 a.m. for Growth Management.
3. July 20, 1988 at 9:30 a.m. for a regular Council meeting.
