1. RANDONCRAFT, DIVISION OF INNOVATOR BOATS INC. for Section I - six 22 ft. non-recreational patrol vessels and one 22 ft. commercial patrol vessel for a total cost of \$189,720.48; terms net 30 days, plus sales tax.
2. SEA WITCH MARINE for Section II - thirteen 155 hp outboard motors with aluminum propellers for a total cost of \$68,451.00; terms net 30 days, plus sales tax.
3. TRAIL-RITE INC. for Section III - six boat trailers for the 22 ft. non-recreational vessels and one boat trailer with electric winch for a 25 ft. deep V vessel for a total cost of \$17,010.00; terms net 30 days, plus sales tax.
