
RESOLUTION NUMBER R- 271264

ADOPTED ON JUN 27 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of the deeds of a fee interest and easements of ROBERT M. EPSTEN and BEATRICE SHIRLEY EPSTEN, husband and wife as joint tenants, as to an undivided 50% interest; and ELLEN BENKLE, a married woman as her sole and separate property, as to an undivided 25% interest; and STEVEN HARRY EPSTEN, a married man as his sole and separate property as to an undivided 25% interest as tenants in common, dated August 31, 1987; H.M. BUSBY and MARILYN K. CARPENTER, husband and wife, as joint tenants, dated September 25, 1987; ETHEL BLUMA BLAKE SCHWARTZ, trustee of the BLUMA BLAKE SCHWARTZ LIVING TRUST, dated October 9, 1987; and MALCOLM B. COUTTS and DOROTHY E. COUTTS, trustees, dated September 24, 1987, all executed in favor of The City of San Diego, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 271264-1, RR- 271264-2, RR- 271264-3 and RR- 271264-4, granting to said City easements for public street purposes in those portions of Pueblo Lots 241 and 242 of the Pueblo Lands of San Diego as more particularly described in the deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named MIDWAY DRIVE and KEMPER STREET.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
