They suggested purchasing a shrink wrap machine to reseal opened packages. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Bradford Jacobsen Amy Navarro	Engineering & Development	280.00	Mr. Jacobsen and Ms. Navarro are both Junior Engineering Aides in the Traffic and Mapping Divisions. They suggested the use of Mylar tags to identify changes. Although savings are difficult to identify, this was considered to be a significant operational improvement.
