BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$22,000 from Mid-City Park Development, Fund No. 39094 to CIP No. 29-669.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$22,000 from CIP No. 29-669, is hereby authorized,

solely and exclusively for the purpose of providing funds for this project.
