RESOLUTION NUMBER R- 271275

ADOPTED ON JUN 27 1988

WHEREAS, for several years, the cities of San Diego, Del Mar, Solana Beach, Encinitas, Carlsbad, Oceanside and the County of San Diego, have been involved in discussions concerning the possible formation of a joint powers agency to address shoreline erosion issues in the San Diego County section of the Oceanside Littoral Cell which extends from Dana Point in Orange County southerly to the Point La Jolla headland north of Scripps Pier; and

WHEREAS, a littoral cell is a length of coastline between two headlands within which sand moves along shore in the same direction; and

WHEREAS, in the Oceanside Littoral Cell, beach sand is created through river deposits and bluff erosion, moves southerly along the coast and is eventually deposited offshore in the La Jolla Canyon near Scripps Pier; and

WHEREAS, the stated purpose of the Beach Erosion Action Committee (BEACH) organization is to promote the restoration of beaches within the littoral cell and to ensure that shoreline erosion control projects in one community do not adversely affect adjoining communities; and

WHEREAS, this organization would also have the power, with the unanimous support of its membership, to seek funds for and carry out beach erosion control projects; and

WHEREAS, it is recommended that The City of San Diego join the Beach Erosion Action Committee, which along with involvement with the Army Corps of Engineers Coast of California Storm and Tidal Wave Study; the Scripps Institution of Oceanography's Local Beach Monitoring Program; SANDAG's Shoreline Erosion Committee and the recently adopted Sensitive Coastal Resource Overlay Zone, will ensure that The City of San Diego continues to play an important role in the preservation of the City's and the region's beaches; and

WHEREAS, in connection therewith, it is further recommended that the Mayor be authorized to execute a Beach Erosion Action Committee Joint Powers Agreement, pursuant to the terms and conditions of the joint powers agreement, on file in the office of the City Clerk as Document No. RR-271275; and

WHEREAS, pursuant to said joint powers agreement, it is also necessary to appoint an elected City official as representative and alternate to said committee; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor be and she is hereby fully authorized to execute a Beach Erosion Action Committee Joint Powers Agreement with other political entities in the Oceanside Littoral Cell to address shoreline erosion issues, pursuant to the terms and conditions of the joint powers agreement, on file in the office of the City Clerk as Document No. RR-271275 .

BE IT FURTHER RESOLVED, that pursuant to section 7 of said joint powers agreement, Councilmember Bruce Henderson is hereby appointed as The City of San Diego's official representative to

said Committee and Councilmember Ron Roberts is appointed as the City's alternate representative to said Committee.
