
RESOLUTION NUMBER R- 271281

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a one-year extension of a Storage Agreement with SAN DIEGO SELF STORAGE SPACE, for Police Department storage space at 611 Island Avenue, San Diego, California, for a total annual rent of seven thousand fifty-six dollars (\$7,056) under the terms and conditions set forth in that Storage Agreement on file in the office of the City Clerk as Document No. RR-268525.

BE IT FURTHER RESOLVED, that the City Manager is further authorized to extend said Storage Agreement on a year-to-year basis for a period not to exceed five (5) years, subject to the budgeting of funds for such Agreement, without additional City Council approval.
