BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,087,409.00 from the Special Projects Wastewater Construction Program (70792) CIP No. 46-147.0 Modified Wastewater

Treatment Facilities Plan, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
