WHEREAS, during consideration of the Special Promotional Programs budget, the Public Services and Safety Committee ("PS&S") discussed the potential of the Motion Picture and Television Bureau (herein called "Bureau") as a City department; and

WHEREAS, funding for this program was recommended to be allocated but implementation withheld pending a decision of the placement of the program, and the PS&S Committee is scheduled to hear this item in July; and

WHEREAS, in order to allow the program to function within the Chamber of Commerce until City Council makes a decision, it is recommended that the current contractual arrangement be continued; and

WHEREAS, the agreement would provide for termination should Council direct that the program become a City department; and

WHEREAS, it is now recommended that the City Manager be authorized to execute such agreement in order to maintain continuity of Bureau operation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego Chamber of Commerce for operation of the Motion Picture and Television Bureau for a period from July

1, 1988 through June 30, 1989 or until such time as determined by Council that the Bureau should be incorporated into City government, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR- 271311.

BE IT FURTHER RESOLVED, that the Auditor and Controller be and he is hereby authorized to expend in support of this program an amount not to exceed \$345,000 from the Special Promotional Programs Budget, subject to adoption of the fiscal year 1989 Annual Appropriation Ordinance.
