
RESOLUTION NUMBER R- 271312

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$400,000 from CCDC Fund 98395, is hereby authorized, solely and exclusively for the purpose of providing funds for the acquisition and right-of-way for Front Street and First Avenue between Island Avenue and Harbor Drive.
