ADOPTED ON JUL 05 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to submit applications to secure FY 1990 Environmental License Plate Fund (ELPF), for the following projects:

1. Mission Bay Northern Wildlife Reserve (aka Kendall-Frost Reserve) - Design of Observation Decks with Narrative Signs and Refencing of the Reserve (\$120,000).

2. Penasquitos Finger Canyon Acquisition (\$180,000).

3. Recovery of Florida Canyon - Phase I (\$100,000).

BE IT FURTHER RESOLVED, that the City Manager, or his representative, be and he is hereby authorized to perform all necessary acts to secure funding for the Environmental License Plate Fund Grant Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to establish special funds which will earn their own interest in accordance with grant requirements for each project actually funded.
