WHEREAS, General Dynamics Corporation (Corporation) has donated \$15,000 to The City of San Diego Regional Youth Employment Program (REGY) for the purpose of providing a private summer youth employment program under which the cost of ten (10) positions at General Dynamics locations will be covered; and


WHEREAS, this program will operate during the summer months of 1988 for youth who will be JTPA eligible and shall be known as the 1988 Summer Hire Intern Project; and

WHEREAS, the City of San Diego Regional Youth Employment Program (REGY) agrees to provide services to operate and administer the project for the Corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with General Dynamics Corporation, for the amount of \$15,000.00 for the purpose of hiring ten young adults and a program coordinator during the summer of 1988, to implement a six-week employment and training program at General Dynamics, under the terms and

conditions set forth in the agreement on file in the office of
the City Clerk as Document No. RR- 271.328 .
