ADOPTED ON JUL 05 1988

WHEREAS, several issues contained in the Memorandum of Understanding between The City of San Diego and the Police Officers Association were reopened for discussion in April 1988; and

WHEREAS, there is a necessity to attract qualified police officer primary pilots in the San Diego Police Department; and


WHEREAS, the Special Weapons and Tactics Team is experiencing a thirty percent turnover for this year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to amend article 40 of the current Memorandum of Understanding with the San Diego Police Department, filed in the office of the City Clerk as Document No. RR-271332, to increase the flight pay differential for the period of July 1, 1988 through June 30, 1989 from \$1.15 per hour or approximately \$200 per month to \$1.75 per hour or \$300 per month.

BE IT FURTHER RESOLVED, that article 55 of the current Memorandum of Understanding between The City of San Diego and the San Diego Police Officers Association, filed in the office of the City Clerk as Document No. RR-271332, be and is hereby amended

to provide for a 50-cents per hour assignment pay for primary and collateral team members of the Special Weapons and Tactics Team for the period of July 1, 1988 through June 30, 1989.
