
ADOPTED ON JUL 05 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and the City Clerk be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Cooperation Agreement with the Housing Authority of The City of San Diego with regard to the construction and/or acquisition of a maximum of 100 units of publicly-owned, low-rent housing, under the terms and conditions set forth in the form of Cooperation Agreement on file in the office of the City Clerk as Document No. RR- 271358.

BE IT FURTHER RESOLVED, that the Council acknowledges that this Cooperation Agreement provides for approximately 100 units of the 2,500 units of publicly-owned, low-rent housing authorized pursuant to the passage of Proposition K on the November 2, 1976, General Election Ballot.
