
RESOLUTION AWARDING A CONTRACT TO SAPPER

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.
