RESOLUTION NUMBER R- 271371

APPROVING MAP OF N.C.W. NEIGHBORHOOD 7,
UNIT 6C.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Douglas C. Paul, Registered Civil Engineer, entitled "N.C.W. NEIGHBORHOOD 7, UNIT 6C, being a subdivision of a portion of Parcel 1 according to Parcel Map No. 13603, filed in the office of the County Recorder of San Diego County December 18, 1984; a portion of the Lot 1 of N.C.W. Neighborhood 7 Units 2 and 6, according to Map thereof No. 11264, filed in the office of the County Recorder of San Diego County June 20, 1985; together with portions of El Camino Real and Hartfield Avenue as dedicated to public use, all being in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Briargate Court and said street is hereby declared to be a public street, and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of sewer, water, drainage and general utility facilities, as granted and shown on the map within the subdivision.


That said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across Lots 7, 8, 9, 10, 11, 12, 13, and Parcels "A" and "B," as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; together with the easements with the right of ingress and egress for emergency vehicle and for the construction and maintenance of sewer, water, drainage and general utility facilities, as well as the building restricted easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
