WHEREAS, Resolution No. R-271242, adopted on June 22, 1988, waived the Permanent Rules of Council in respect to meeting dates and times in order to schedule additional meetings for Growth Management and General Plan purposes; and

WHEREAS, such additional group of meetings was deemed necessary in order to conclude Council deliberations and decisions in time for the November, 1988 ballot; and

WHEREAS, in setting said schedule, the necessity for a regular Council meeting on July 18 and 19, 1988 was overlooked and is now deemed necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Resolution No. R-271242, adopted June 22, 1988, which establishes and schedules various dates and times during the month of July, 1988, for specified purposes, be and the same is hereby amended by adding to and amending section 2 thereof to schedule a regular meeting of the City Council at 10:00 a.m. Monday and Tuesday, July 18 and 19, 1988.

BE IT FURTHER RESOLVED, that the Permanent Rules of the Council, Municipal Code section 22.0101, Rule 1, be and it is hereby waived for said purpose.
