
ADOPTED ON JUL 11 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a second amendment to the agreement with AMERICAN RED CROSS, SAN DIEGO/IMPERIAL COUNTIES CHAPTER, to provide lift-equipped transportation to eligible Dial-A-Ride passengers, under the terms and conditions set forth in the Second Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 271376.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$198,430 from Fund 19631, Dept. 8990, Org. 221, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above second amendment to agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
