
ADOPTED ON JUL 11 1988

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$13,500 from Fund 100, Dept. 601, Org. 102, Acct. 4151, Job Order 60102, to supplement funds previously authorized by Resolution No. 269289, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
