WHEREAS, The City of San Diego wishes to enhance the physical fitness level of all San Diego police officers; and

WHEREAS, The City of San Diego is implementing a mandatory fitness program called Fitness, Image and Training ("F.I.T.") for all sworn personnel of the San Diego Police Department; and

WHEREAS, the F.I.T. Program will include an initial fitness profile appraisal and quarterly testing of cardiovascular condition, strength, flexibility and body fat composition thereafter; and

WHEREAS, the City has need of a qualified medical services provider to conduct the fitness profile appraisals which include a health risk assessment and educational and training services; and

WHEREAS, monies are available therefor in the Fiscal Year 1989 budget for the Police Department (Health Management); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Sharp HealthCare to provide fitness profile appraisals and education and training services to all sworn members of the San Diego Police Department, pursuant to the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-271380.
