
ADOPTED ON JUL 11 1988



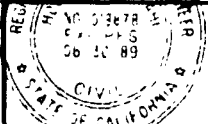
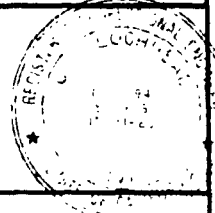
**LEGEND**
