

RESOLUTION NUMBER R-271393

ADOPTED ON JULY 11, 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of four (4) grant deeds of TIERRASANTA L-L PARTNERSHIP, a California general partnership, executed in favor of The City of San Diego, all bearing the date of January 29, 1988, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-271393-1, RR-271393-2, RR-271393-3 and RR-271393-4, granting to said City portions of Parcels 2, 9 and 10 of Parcel Map 14737, totaling 2.81 acres, for park and open space purposes, as more particularly described in said deeds, be, and the same is hereby approved.


BE IT FURTHER RESOLVED, that the acceptance by the City Manager of a Deed of Release, executed by the Secretary of the Interior, a copy of which is on file in the office of the City Clerk as Document No. RR-271393-5, which deed releases open space restrictions over portions of Parcels 1 and 2 of Parcel Map 8547, in the City of San Diego, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that Parcels A, C-1 and C-2 of said Deed of Release are hereby dedicated as and for public streets, and Parcels A and C-1 are hereby named PORTOBELO DRIVE, and Parcel C-2 is hereby named CAMINO PLAYA BAJA.

BE IT FURTHER RESOLVED, that the City Manager's acceptance of the above specified four (4) grant deeds shall be contingent upon and title shall not pass to the City until a sweep of the subject property has been accomplished.

BE IT FURTHER RESOLVED, that the City Clerk shall forward the deeds and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
