RESOLUTION NUMBER R- 271428

ADOPTED ON JUL 20 1988

WHEREAS, several months ago, a representative from San Diego Gas & Electric Company proposed that they bring the "Up With People" group to San Diego as a benefit for the Drug Awareness Resistance Education (D.A.R.E.) unit of the Police Department; and

WHEREAS, after contact with the Police Department, they proceeded with their plans; and

WHEREAS, "Up With People" will begin public appearances the week of June 6 with a mini-cast and the full cast will arrive in the City on June 13 for a five-day stay; and

WHEREAS, public performances and a cast party are planned for Friday, June 17 and Saturday, June 18 at the Civic Theater, with all proceeds after expenses to be donated to D.A.R.E.; and

WHEREAS, the exact amount of the donation will depend on ticket sales and cannot be determined at this time, but estimates range as high as \$10,000; and


WHEREAS, this action will allow The City of San Diego to accept the donation from San Diego Gas & Electric Company to further aid the Police Department's D.A.R.E. program, said funds to be deposited in the D.A.R.E. Special Trust Fund 10135; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is fully authorized and empowered, for

and on behalf of said City, to accept a monetary donation from the San Diego Gas & Electric Company, said amount to be determined in the near future, said funds to aid the Police Department's Drug Awareness Resistance Education unit.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby directed to place said funds accepted above in the D.A.R.E. Special Trust Fund 10135, to be used solely and exclusively for the purpose for which the fund was established.
