WHEREAS, Captain Michael Caprio, Assistant Chief of Staff for Housing to Commander Naval Base, San Diego (Housing Liaison Officer) has improved the quality of life for Navy personnel in Murphy Canyon and throughout San Diego; and

WHEREAS, in his nine months on the job, Captain Caprio identified the most critical issues regarding the interrelationship between Navy and civilian housing; and

WHEREAS, Captain Caprio resolved a number of those issues and he started the process to solve long-term problems; and

WHEREAS, Captain Caprio coordinated efforts to provide to the Murphy Canyon area services such as its recreation center, the YMCA, and better schools; and

WHEREAS, Captain Caprio started the Teen Community Council to involve Murphy Canyon's youth in making decisions affecting themselves; and

WHEREAS, Captain Caprio pushed for adolescent programs and a Teen Recreation Center; and


WHEREAS, Captain Caprio retired from the Navy effective the first of July, 1988; NOW, THEREFORE,
