
WHEREAS, the Uptown Planners ("Planning Group") was recognized by the City Council as the official community planning committee for the Uptown Community Planning area in June 1969; and

WHEREAS, the Planning Group has revised its bylaws to change its name from "Uptown Community Planning Committee" to "Uptown Planners," change procedures on member absences and vacancies, change the date for holding elections, simplify automatic eligibility requirements, and delete language which required new applicants for membership to wait thirty (30) days before becoming members; and

WHEREAS, revisions to the bylaws are consistent with Council Policy 600-24; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation of the Planning Department to adopt the amended bylaws for the Uptown Planners, a copy of which is on file in the office of the City Clerk as Document No. RR-271434, is hereby approved.
