WHEREAS, H.R. Bill 4868 (Hughes), the Antidrug Abuse Amendments Act of 1988, would authorize the continuance of programs created by the Omnibus Antidrug Abuse Act of 1986; and

WHEREAS, H.R. Bill 4868 (Hughes) would authorize funding for state and local law enforcement programs, education, treatment and rehabilitation; and

WHEREAS, this bill meets the criteria established for a support position as stated in the legislative policy guidelines, Council Police 000-19, VIII.2.1; and

WHEREAS, the Intergovernmental Relations Department Report No. 88-22 recommends supporting H.R. Bill 4868 (Hughes) with certain amendments thereto; and

WHEREAS, the Rules Committee reviewed IRD's recommendations at the regularly scheduled Committee meeting of July 6, 1988 and approved same unanimously; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation to support H.R. Bill 4868 (Hughes) and seek amendments thereto, as set forth more specifically in Intergovernmental Relations Department Report No. 88-22, be and the same is hereby approved and adopted.
