BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of \$62,606 by ROGER RANDAZZO, an individual, dba RANDAZZO CONSTRUCTION COMPANY, meeting specifications for NORTHERN POLICE STATION PROPERTY ROOM EXPANSION, Base Bid and Additive Alternate No. 1, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 118955.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$19,246 from Capital Outlay Fund 30245, CIP No. 36-031.1 NORTHEASTERN AREA STATION to CIP No. 36-047 NORTHERN PROPERTY ROOM EXPANSION.

3. That the expenditure, not to exceed \$19,246 from Capital Outlay Fund 30245, CIP No. 36-047 NORTHERN PROPERTY ROOM EXPANSION to supplement funds previously authorized by Resolution No. 270888, adopted on May 9, 1988, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
